HAMINA LNG OY - INVITATION FOR ADDITIONAL CAPACITY ALLOCATION

Hamina LNG Oy has available capacity for Gas Year 2024 (1.10.2023 – 30.9.2024) after the Annual Capacity Allocation Procedure, that will be allocated in the Additional Capacity Allocation Procedure. The market participants are invited to request capacities for storing LNG in the Terminal's LNG tank (the "Storage Service"), and for the Terminal's regasification and injection services (the "Regasification Services"). The service capacities are allocated in "Slots". For the Gas Year 2024, the Available Slots at the Terminal are as follows:

- 230 Slots for Storage Service, where a Slot equals to 650 MWh of LNG storage capacity.
- 5750 Slots for Regasification Service, where a Slot equals to one (1) MWh/Gas Day.

Please refer to the approved Terminal Rules for Gas Year 2024 for additional definitions. The Terminal Rules can be found on Hamina LNG website: https://www.haminalng.fi/materials/instructions-and-rules/

This invitation remains valid until further notice on the Hamina LNG website. The following principles are followed regarding reservations:

- The capacities will be allocated on a first-come, first-served basis.
- Capacity for Storage Service can be reserved for the remainder of the gas year.
- Capacity for Regasification Service can be reserved on a yearly or quarterly basis. In addition, monthly capacity for Regasification Service is auctioned at the end of each month on Hamina LNG website.
- Fixed truck loading capacity can be reserved monthly.

Capacity booking procedure for available capacity (new terminal users):

- 1) To begin the application process, please send the following documents to Hamina LNG's email info@haminalng.fi with the subject "Hamina LNG application documents"
 - copies of its registration certificate, issued according to the law of the jurisdiction in which it is established, and its articles of association or other founding documents,
 - b) copies of the passports or id cards of the signatory or signatories of the Terminal Capacity Allocation Request Form, and evidence of these persons' authorization to submit the Application with binding effect for the Applicant,
 - c) audited financial statements from the last three (3) years or, if the company has been founded more recently, since the founding of the company,

- d) a written confirmation that the applicant has the necessary LNG procurement channels and a vessel suitable for delivering LNG,
- e) information on whether the Applicant is a Registered User, and if so, a copy of the documentation evidencing such status.
- 2) Hamina LNG responds with Terminal Services Contract (TSC) draft and a <u>binding</u> capacity booking form.
- 3) Fill out the binding capacity booking form and send it to Hamina LNG.
- 4) The TSC shall be signed with a successful applicant.
- 5) When the TSC has been signed and the contractual obligations (such as provision of a Bank Guarantee) for starting to use the terminal services are fulfilled, the applicant can start using Hamina LNG's services.
- 6) Hamina LNG will provide login information to the customer portal on Hamina LNG's website.
