

HAMINA LNG OY - NOTIFICATION OF SPOT CAPACITY SERVICES

Hamina LNG Oy is offering spot capacities for April 2024 – June 2024. The spot capacities are available for Terminal Users, meaning that new market participants wishing to receive spot capacities may request to enter into Terminal Services Contract (please see the Spot capacity booking procedure for new Terminal Users at the end of this notification letter). Annual capacity for the rest of the current Gas Year is also available, and all capacities will be allocated on a first-come, first-served basis.

The market participants are invited to request capacity for storing LNG in the Terminal's LNG tank (the "Storage Service") and for the Terminal's regasification and injection services (the "Regasification Services). The service capacity is allocated in "Slots". Fixed truck loading capacity can also be reserved in advance for the availability period.

In addition, monthly Regasification Service capacity is auctioned at the end of every Gas Month for the next Gas Month in accordance with Terminal Rules section 36.2. An announcement will be made on the Terminal Website https://www.haminalng.fi/materials/announcements/ at the latest five (5) business days before the change of the Gas Month. Non-allocated Regasification Service capacity can also be utilized by Terminal Users as day or intraday capacity.

The spot capacities must be booked 5 days before the start of the spot. Spot capacity bookings can be made for any one-month period during the availability period. Spot capacities will be allocated on a first-come, first-served basis, i.e., Applications received first will be considered first. Bookings will be made with the <u>Binding</u> spot capacity booking form (appendix 1 of this notification letter).

Spot Capacity Service is defined in section 19 of the Terminal Rules and Operative Loss Quota is defined in section 29.1.7.

Spot capacity booking procedure for new Terminal Users

- 1) To begin the application process, please send the following documents to Hamina LNG's email info@haminalng.fi with the subject "Hamina LNG application documents"
 - a) copies of its registration certificate, issued according to the law of the jurisdiction in which it is established, and its articles of association or other founding documents,
 - b) copies of the passports or id cards of the signatory or signatories of the Terminal Capacity Allocation Request Form, and evidence of these persons' authorization to submit the Application with binding effect for the Applicant,
 - c) audited financial statements from the last three (3) years or, if the company has been founded more recently, since the founding of the company,
 - d) a written confirmation that the applicant has the necessary LNG procurement channels and a vessel suitable for delivering LNG,
 - e) information on whether the Applicant is a Registered User, and if so, a copy of the documentation evidencing such status,
 - f) filled <u>Binding</u> spot capacity booking form (appendix 1 of this notification letter).
- 2) The applications are processed in order of arrival.
- 3) Hamina LNG responds with appendices of the Terminal Rules, including Terminal Services Contract (TSC) draft.
- 4) The TSC shall be signed with a successful applicant.
- 5) When the TSC has been signed and the contractual obligations (such as provision of a Bank Guarantee) for starting to use the terminal services are fulfilled, the applicant can start using Hamina LNG's services.
- 6) Hamina LNG will provide login information to the customer portal on Hamina LNG's website.
